**Contract Agreement** between Island Weigh 95, Inc. (Tag Supplier) and the License Holder

Terms of Agreement

As an approved Department of Fisheries and Oceans (DFO) Tag Supplier, Island Weigh 95, Inc. agrees to supply and issue tags in sequential numbers to the License Holder and the License Holder agrees to purchase tags in sequential numbers from Island Weigh 95, Inc. for the 202 fishing season.

Both, Island Weigh 95, Inc and the License Holder agree that all information collected by Island Weigh 95, Inc. shall remain confidential and used solely for the purpose of ordering and administering tags. The License Holder agrees to release all records of the issuance of tags to DFO on a daily basis or to the License Holder as requested. This allows DFO to ensure the License Holder is in compliance with the protocol for the Atlantic Commercial Fishery. The License Holder must comply with their licensing conditions and the protocol for the Atlantic Commercial Fishery.

Fee:

Tag fee is \$0.45 + taxes + shipping fees when applicable (prices are subject to change). The fee per tag plus applicable shipping fees shall be paid to Island Weigh 95, Inc. prior to issuance or distribution of any tags. Tags may be picked up at our office or shipped at the cost of the License Holder.

Replacements Tags:

Island Weigh 95, Inc. may issue tags to the License Holder on an as need basis and will only provide replacement tags to those Licence Holders who obtained their initial tag allotment from. Replacement Tag fee is \$3.00 + taxes + shipping fees when applicable (prices are subject to change).
