## Terms of Agreement

As an approved Department of Fisheries and Oceans (DFO) Tag Supplier, Island Weigh 95, Inc. agrees to supply and issue tags in sequential numbers to the License Holder and the License Holder agrees to purchase tags in sequential numbers from Island Weigh 95, Inc. for the 20 fishing season.

Both, Island Weigh 95, Inc and the License Holder agree that all information collected by Island Weigh 95, Inc. shall remain confidential and used solely for the purpose of ordering and administering tags. The License Holder agrees to release all records of the issuance of tags to DFO on a <u>daily</u> basis or to the License Holder as requested.
